2. Name

The name of the Trust shall be **Sri Prasanna Veeranjaneya Seva Trust (SPV Seva Trust)**

3. Place

The principal office of the Trust for the time being shall be at 2nd Floor, Sri Prasanna Veeranjaneya Temple, 4th Main, Mahalakshmpuram, Bengaluru 560086 or such other place as the Trustees may decide from time to time decide. The Trust may also carry on its work at any other place or places, as decided by the Trustees.

4. Objects :

The objects of the Trust shall include the following:-

- i. To give stipends, scholarships, travelling expenses, allowances and monetary aids to students and scholars in India and abroad;
- ii. To spread or assist in spreading education including physical and moral training;



- xiv. To give scholarships, awards, stipends, honoraria to such individuals as have devoted themselves to the various public causes in line with the objects of the trust;
- xv. To assist and / or lend the movable or immovable properties and assets of the trust without profit motive in such institutions, which are conducive to the achievements of the objects of the trust;
- xvi. To grant, pay or give scholarship, stipends, prizes, rewards and other financial assistance or help in cash or kind to students with a view to help them in prosecuting their studies in schools, colleges, educational institutions in India or abroad;
- xvii. To provide safe drinking water to the disadvantaged sections of the society both in rural and urban areas and needy citizens;
- xviii. To provide sanitation facilities to the economically disadvantaged sections of the society.
- xix. To assist small and marginal farmers in agriculture and horticulture;

- xxviii. To contribute to charitable institutions (registered under Section 12A of The Income Tax Act, 1961) having similar objects of the Trust;
- xxix. To undertake, carry out and support any other activity calculated to promote good environment in the society especially in the case of the poor, needy and underprivileged free of cost;
- xxx. To receive voluntary donations in cash or in kind from individuals or associations of the purpose of carrying the objects of the trust;
- xxxi. The Trustees shall also be entitled to carry out such other activities as they may think proper and necessary which can be decided by a majority from time to time. The beneficiaries of the trust can be to any individual/s irrespective of his/her/their, gender caste, creed or religion.

5. Funds

The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.

6. Utilization

6.1 The funds and the income of the Trust shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividends, etc. The Trustees shall hold and possess the said sum and the income (hereinafter for brevity's sake referred to as " The Trust Fund", which expression unless repugnant to the subject or context, also include any other property and investments of any kind whatsoever into which the same or any part thereof may be converted invested or varied from time to time and those which may be or come to their hands by these presents including all fees, gifts and donations either in cash or other properties movable or immovable whether by gifts, bequests or legacies or otherwise howsoever which may be made or paid to or received by the Trustees from time to time for the purpose of these presents) on behalf of the Trust subject to the powers, provisions, agreements and declarations hereinafter contained.

6.2 The funds and the Income of the trust shall be solely utilized for achievement of the objects of the trust and no payment shall be made to the trustees by way of profit, interest, dividends etc. Where necessary separate funds could be earmarked for execution, undertaking and managing specific projects/activities of the Trust and distinct and separate bank accounts could be opened therefor to monitor fund utilization for such projects and activities.

6.3 In the administration of the Trust it shall be open to the Trustees to give any relief they are authorised to do not only by making gifts in money but also in kind to the beneficiaries. It is hereby made clear that the benefits of

7. Power of Trustees

The Trustee or trustees for the time being of the said Trust shall have the following powers and the said Trust and/on the Trust Properties shall be governed by the following rules and regulations: -

- To enter any contract on behalf of the Trust.
- To manage all the assets and/or properties of the trust including the conduct of business.
- To look into the management of the Trust.
- To invest the funds of the trust, in bank or in the purchase of company shares or securities or other movable and immovable properties.
- To open & maintain accounts with scheduled Banks and authorize operation of such accounts by any of the members of the Board of trustees or any employee, functionary or appointee of the Trust jointly or severally and to draw, accept, endorse, discount and/or negotiate negotiable and quasi-negotiable instruments on behalf of the Trust.
- To raise loans from financial institutions / Other Parties, with or without offering Trust property as collateral.
- To receive gifts, grants, endowments and donation in cash or kind from anyone for the objects of the trust.
- To pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;
- To institute, prosecute and to defend all suits, legal and other proceedings. Also to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed.

 - s. The trustees may reimburse themselves and pay and discharge out of the trust fund all expenses incurred by them in or about the execution of the trust duties under these presents including traveling expenses.
 - t. All the trustees unless they voluntarily resign or otherwise decide shall continue to be the trustees during the term of their natural lives.
 - u. The power to appoint new or additional trustees, but so as not to exceed the maximum number and fill vacancies in the office of the trustees, shall vest in the continuing trustee or trustees.
 - v. To appoint committees and sub-committees from among the members of the Board and or along with others and assign duties, and to frame such rules of business as the Board shall think fit, and to alter or vary the terms of business, which shall not be inconsistent with the terms of these presents.

8. Bank Account

All income, subscription and pecuniary donations for the general purposes of the Trust and the income, investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a banking account with any scheduled bank for the purpose of the Trust. The Trustees shall be entitled from time to time to open, operate and maintain a bank account or accounts in the name of the said Trust to be operated jointly by any two Trustees, at such bank or banks as they may from time to time decide and may at any time pay or cause to be paid or withdraw any money forming part of the Trust Fund or the income thereof to the credit of any such account or accounts and either by way of fixed deposit or current account or any other account.

9. Investments:

9.1 Subject to the provisions of the deed, the funds of the Trust shall be invested in the modes specified under the provisions of section 13 (1)(d) read with section 11(5) of the Income Tax Act 1961 and as mentioned from time to time.

9.2 The trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries under the trust. The investments of the trust fund including those in immovable properties shall be made or kept in the name of the Trust and shall be operated by any of the two Trustees.

10. Management of Trust

- The number of Trustees of the said Trust shall not be more than 10 not less than 2. The Board of Trustees shall manage the Trust and they shall remain for life unless decided otherwise, by each of them by submitting a return letter of resignation. - If a Trustee shall disclaim or die or become insane or refuse or neglects to act as a Trustee or resign or otherwise become incapable or unfit to act in the Trusts of these presents, he / she shall be deemed to have vacated the office of the Trustee but subject always to the maximum and minimum number of Trustees mentioned in sub- clause (a) thereof. It is hereby expressly declared that a Trustee leaving India or residing out of India shall not on that ground alone be deemed to refuse or neglect to act as Trustee or to become incapable or unfit to act in the Trust of theses presents.
- Members who shall be appointed or nominated by the Board of Trustees shall also assist the Trust. Such appointment or nomination shall be made at the meeting of the Board of Trustees and shall be valid only after a simple majority has approved it. The members shall consist of a panel of professionals, people or persons holding positions in public life and the like. Their role in the affairs of the Trust shall be restricted to the rules and norms laid down by the Board of Trustees from time to time or as per the rules specifically included in the Byelaws of the Trust.

11. Rules, Regulations and Bye-Laws of the Trust:

It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the said Trust as they shall think fit and to alter or amend or vary the same from time to time and to make new rules and regulations.
